## NOMINATION FOR NFH RECREATION ADVOCATE OF THE YEAR AWARD

They will be honored at the NFH annual convention.

**WHO IS ELIGIBLE TO RECEIVE THE AWARD?** Any USFS employee who works with recreation residences.

**WHO MAY NOMINATE?** Any NFH member—individual, representative of a tract or state association of cabin users.

**WHAT TO SUBMIT?** The completed questionnaire and letters of recommendation. Letters may come from individual permittees, representatives from the state, region or the National Forest served concerning the nominee's role in furthering the public service mission of the FS and the enjoyment by permittees, their families and guests. Documentation of previous awards or recognition may be included and, if available, a photo.
